#### Build the Domestic Church and Strengthen Parish Life

Here we are, days into December and already, we are busy preparing to celebrate the birth of our Savior, our Lord, Jesus Christ.

His journey started like many of ours, by being a young boy and growing up into a teenager and suddenly began to preach in synagogues. Many people started to follow Him so that they could listen to what he had to say. He then recruited some 12 apostles, this was so that they too would continue to spread His words. As people listened, they started to understand what he was teaching and many decided to change their lives to be able to follow the Lord. More than 2000 years later, many still convert, many others find it important to baptize their children, raise them in our Church and by doing so, our Church grows.

This is very similar to our Order. Father McGivney had a vision of something much bigger than himself. To do something good for others, he approached catholic men from his Church and expressed his vision to help protect widows and orphans, and our Order was created. Today, if we want to continue to grow, we must recruit so we can continue the good work that is needed in our communities, Churches, and parishes.

Star Council awards: To demonstrate the importance of this award, during the State Deputies mid-year meeting in San Antonio Texas, our Supreme Knight announced that again this year, any council that qualifies and receives the Star Council award, will be eligible for a per capita discount of \$4.50 per paying member.

Can you imagine that, for a council of 100 members, this would represent a \$450.00 rebate that could go to support a charity, help the needy or any other great cause your council participates in. Does your council qualify? It is a proven fact that 95% of councils already organize enough programs to complete the SP7 application which helps in meeting your quotas of new and insured members.

Only a few steps are missing; which are paying your per capita to Supreme and State, and confirming your forms 1728 and 365 have been filed.

This past year, Ontario State had 44 Star Council Awards and we want more this year. We want to help you achieve this status, so if in need, please don't hesitate to ask one of your State Board officers, State Directors or Chairmen. We want your success!

### Impressive milestones were reached in November.

First, the Order reached 100 billion dollars of insurance in force, and, later in the month we welcomed our 1.9 millionth member. Being part of a solid, worldwide organization with this amount of members working together to do good where it is

needed, and all of us can sleep well at night because we have secured our families with our well-funded insurance company is a wonderful gift. I know we are part of the best organization, and it is our duty to introduce this gift to others.

"Our Mission to build the Domestic Church and Strengthen Parish Life" is how Supreme Knight Carl Anderson's opened our State Deputies Mid-Year meeting and followed up by explaining his vision. For example, the Knights initiated one of the largest vocations programs in history. Through our Refund Support Vocation Program and scholarships, we have provided \$68 million to more than 115,000 men and women pursuing their vocations.

Also, the Order will begin to move away from establishing councils dependant of home corporations; instead we will promote parish based councils aligned with Father McGivney's original vision of the Order.

A greater focus on Programs that will include more family member activities. We must realize that when council members work hard running activities to create revenue to offset costs of their buildings, they are not doing Knights work as to help their church, communities, youth, and families. We need to switch this direction of thoughts.

As we are days away from Christmas, we are always in the mood to give and receive. We go out purchasing gifts for our loved ones, buying a little something for the neighbour who helps with the snow, or the bus driver who has the responsibility of transporting your children to and from school. We love to give as a sign of appreciation. But, let's not forget we like to receive as well.

# *Bâtir l'Église domestique et renforcir la vie paroissiale an français*

Nous voici rendus au début de décembre et déjà nous sommes occupés à nous préparer pour célébrer la naissance du Sauveur, notre Seigneur Jésus Christ.

Son parcours a débuté comme la plupart de nous en étant un jeune garçon, il est devenu adolescent et s'est soudainement mis à prêcher dans les synagogues. Beaucoup de personnes se sont mis à le suivre afin d'écouter ce qu'il avait à dire. Il a ainsi recruté 12 apôtres afin qu'ils puissent continuer à propager Ses paroles. Alors que les gens écoutaient, ils ont commencé à comprendre ce qu'Il enseignait. Plusieurs ont décidé de convertir leur vie pour être ainsi en mesure de suivre le Seigneur. Quelque deux mille ans plus tard, plusieurs continuent à se convertir et plusieurs autres trouvent important de faire baptiser leurs enfants, de les élever dans la foi de notre Église et, ce faisant, notre Église grandit.

Ceci est très similaire pour notre Ordre. Le Père McGivney avait une vision de quelque chose de beaucoup plus grand que lui-même. Aujourd'hui, nous continuons à vouloir grandir, nous devons recruter pour être en mesure de continuer le bon travail nécessaire dans nos communautés, nos églises et nos paroisses. Prix pour les Conseils Étoiles. Afin de démontrer l'importance de ces prix, durant notre réunion mi-mandat des Députés d'État à San Antonio Texas, le Chevalier Suprême a annoncé que cette année encore, tout Conseil qui qualifie et reçoit le prix du Conseil Étoile, se verra octroyé un rabais de 4,50\$ par membre payant. Imaginez pour un Conseil de 100 membres, ceci équivaut à 450\$ qui pourraient être dirigés vers une œuvre de charité de votre choix, ou pour aider des gens dans le besoin ou encore pour n'importe quelle grande cause auguel participe votre Conseil. Qu'a-t-on besoin pour se qualifier? Il est prouvé que 95% des Conseils organisent déjà suffisamment de programmes pour la demande SP-7, il y a donc l'atteinte des quotas de vos nouveaux membres et d'assurances, d'avoir payé le per capita au Suprême et à l'État, et d'expédier les formulaires 365 et 1728. La dernière année, quarante-quatre (44) Conseils ont atteint cette reconnaissance importante et cette année, nous en voulons encore plus. Nous voulons vous aider à atteindre cette marque de reconnaissance, alors si vous avez besoin, s'il-vous-plait, veuillez demander de l'aide à un officier du Bureau d'État, à un Directeur d'État ou à un Président de programme. Nous voulons votre succès!

Le mois de novembre a été un excellent mois pour l'atteinte de buts particuliers pour notre organisation.

Nous devons réaliser que lorsque les membres de Conseil travaillent fort à produire des activités pour créer des revenus pour contrer les coûts de leur bâtiment, ils ne font pas le travail des Chevaliers qui consistent à aider leur église, communauté, jeunesse et famille. Nous avons besoin de changer cette façon de penser.

Alors que nous ne sommes qu'à quelques jours de Noël, nous demeurons toujours dans l'esprit de donner et de recevoir. Nous sortons acheter des cadeaux pour ceux que nous aimons, un petit quelque chose à notre voisin qui nous aide avec la neige, ou pour le conducteur d'autobus qui a la responsabilité de transporter notre enfant, ou nos enfants, sur le trajet de l'école. As your State Treasurer, I have to examine our Order's "financial health" and do whatever I can to encourage you to expend any additional effort that might be necessary in order to "keep the ship afloat". To this end I bring to your attention a few items and ask that you assist me in improving the current status and helping me put the State's financial standing on a solid footing as we enter 2016.

The per capita payments must be brought up to date. My Brothers, I cannot over-emphasize the importance of this. Invoices have long since been prepared and distributed but still, for some reason or other, there is an inordinate number of Councils still in arrears. I ask each and every "Brother in authority" to attend to this matter without delay. The time for 2016 invoicing is upon us already so let us not allow our Councils to slip any further behind in their commitment and responsibility.

The State Charities Lottery has been addressed; changes to the prize structure and number of tickets printed (and the method of distribution) have been made. The sale of these tickets and timely remittance of the proceeds is up to you. In the past you have been made aware of the importance of this lottery so I will not dwell on it here. Once tickets are received by your Councils, let's "roll up our sleeves" ... don't delay ... and strive to make this year's lottery a sell-out.

#### Home Corporations

#### Home Corporations

Over the years, many councils have established Home Corporations to build and manage permanent facilities such as halls or other gathering spaces. These facilities are used by councils for their meetings and to host charitable and fraternal programs for the church and community.

In recent years these facilities have become expensive to maintain and many Home Corporations are struggling to raise the funds to do so as they compete with hotels and banquet facilities for rentals. Financial struggles strain the relationship between councils and Home Corporations and often lead to difficulties.

To avoid difficulties, in 2014 the Supreme Council established a policy requiring written agreements governing terms of use and charitable distributions. A "Handbook for Councils Using Home Corporation Facilities" was published that contains background information, instructions and template agreements.

In the upcoming months, councils that use Home Corporation facilities will be asked to enter into legal agreements with the corporation.

The reason for this is to protect both the council and corporation in the event of a dispute and provide mechanisms for resolving disputes without having to involve the State or Supreme Advocates. The content of the agreements address the most common issues between councils and corporations.

Please note that these agreements in no way involve the Ontario State Council or the Supreme Council. In fact, they are designed to avoid our involvement as much as possible by empowering councils and Home Corporations to solve problems on their own. We are in the process of surveying the councils in Ontario to determine which ones are associated with Home Corporations so that we can send the Grand Knights the "Handbook for Councils Using Home Corporation Facilities".

#### **Resolutions**

I would like to remind councils that the deadline for submitting resolutions for the 2016 Ontario State Convention is January 15, 2016. The resolutions template is available under Forms in the Officers menu on the Ontario State web site. After the council has approved the resolution it should be sent to the Ontario State Office.

This package also contained useful information for anyone wishing to support the Guild: a prayer card supporting the canonization of Father McGivney, the Guild's purpose, objectives, and means of support, as well as a schedule of masses held at St. Patrick's Basilica in Ottawa where the Honoris is held. It also includes a description of the third class relic of Fr. McGivney which can be viewed at the Honoris.

This package, which is readily available from the committee of the Honoris, is specifically designed to inform anyone interested in supporting the Honoris as well as providing concrete steps on how one can become involved and join the Guild.

#### The Syrian Refugee Crisis

Unlike the Syrian economic refugees walking through Europe, most of the Christian Syrian refugees are located in Lebanon, Jordan and Turkey and they represent the poorest of the poor.

Lacking money to travel to Europe, lacking higher education or easily transferable skill sets, they have nothing to barter, and they rely almost entirely on the generosity of other citizens of the world for their subsistence. Their only crime is that they are Christian, they seek peace rather than war, and hope rather than despair.

Their plight calls to our humanity and we, as Knights of Columbus, should respond to this plea. And I am pleased to say that the Knights of Columbus Christian Refugee Relief Fund has already contributed more than \$4.5 million to help so far. But we can do more! And many brother knights want to do more!

Councils may help by participating in the Order's Solidarity Cross program. Individuals can also help directly by visiting: www.christiansatrisk.org and make a direct contribution.



It is my hope that in the near future Ontario will regain a directorship as well.


I urge every member to work diligently to regain the leadership that we have traditionally held in our Province.

#### *Membership Is Everyone's Business*

Retention begins during the recruitment process. The more a man knows about the Order, the greater his interest in the Knights of Columbus will be.

Even the best recruitment efforts are worthless if a council can't keep its current members.

If an active member has stopped attending meetings, a council representative or his proposer should call to inquire if he is well, and to let him know he has been missed and is needed.

The District Deputy should pay close attention to any councils exhibiting problem characteristics - council under suspensions for non payment of Supreme Council assessments and councils that are not suspended but are showing "warning signs" including:

- low membership (less than 30 members)
- failure to add at least one new member per year

Membership is everyone's business. There are many eligible Catholic men who have never been asked to join with us in supporting our programs.

It could be a relative, friend or neighbour. Many will join if asked and even if at first they say no, ask again. Give all catholic men you know the opportunity to practice their faith by joining the Knights of Columbus. Invite them to share with us the joy of helping those in need and by working together as Catholic men in our communities and church to fulfill the Gospel message.

YES, We are proud to belong to the best Catholic, Family Service Organization in the world today.

#### As Knights of Columbus members we should recruit as never before and share the job of membership.

The RSVP Program is the perfect way to help our dedicated men/women studying towards Priesthood or Vows as Nuns. Each \$500 donation will get the sponsoring Council a \$100 Refund from Supreme (up to \$400 Refund for each person sponsored). Participating in the Supreme Form #2863 RSVP Program will also fulfill the "Church Activities" category of the SP-7 Columbian Award Application, since it counts for the full 4 Church Activities in the SP-7 Columbian Award Application: it's a Win-Win-Win situation.

As you know, many of our Ontario Councils have been generous in their support of our Seminarians via the RSVP Program. But, many Councils are not even aware that sponsoring women who are studying towards their Vows as Nuns is also an option available via the Supreme RSVP Application (please refer to the Instructions of the RSVP Application, which states this clearly). As you may also know, the course of study from start to Final Vows is 7 to 8 years for these dedicated women studying towards their goal of becoming Nuns to service our Church and communities.

Should your Council wish to help a Seminarian or a woman studying towards her Vows as a Nun, please contact me if your council does not have the name of a particular Seminarian or a particular woman studying towards her Vows as a Nun, and I will provide your Council with particular contact information in this regard. Also, please note that the best time to sponsor a Seminarian or a woman studying towards her Vows as a Nun is in the middle of the study year-during Fall/Winter, before Spring.

Although the RSVP Form #2863 is due for filing by June 30, the sponsorship should occur months before that, if possible.

Remember, without our Priests and Nuns there would be no Catholic Church, and without our Catholic Church, there is no Knights of Columbus. Let us all support these dedicated men and women via the Knights of Columbus RSVP Program.

# How to grow and strengthen your council

A council needs to give its members a sense of belonging and to attract Prospects we must give them a good reason to join.

To keep members from losing interest they need a variety of activities to choose from and an opportunity to volunteer – that is why they joined!

Don't forget about your members who have been with your council for years and are no longer attending your meetings or activities.

Lack of conscientious freedom for health care workers to avoid euthanasia procedures

Dearest Brothers,

It has been a busy and worrisome year. The Supreme Court of Canada (SCC) has inflicted euthanasia upon our country.

To make matters worse, there is currently little protection for conscientious freedom of health care workers to avoid participation in assisting in the death of patients. Several provincial regulators of doctors and health care workers have found it acceptable to compel doctors to be complicit in acts which they find morally unacceptable.

Currently, regulatory bodies in Quebec, Ontario, and Saskatchewan have changed their governing norms so as to force a physician to provide an "effective referral", or in cases of emergency, to perform an objectionable service against their will or suffer exposure to regulatory reprimand.

The compulsion for referral is not acceptable as it still violates a physician's conscience. For Catholics, it also means being complicit in an intrinsically evil act, or full participation in grave sin. In addition to our prolife work in standing up for all human life from conception until natural death, let us also support our Catholic doctors, nurses, and indeed all health care workers who refuse to engage in the intrinsically evil act of mercy killing.

This is not an issue to defer to some distant time in the future. The time for us to stand for conscience rights is now.

Whereas, the current federal government and its leader have already indicated enthusiasm for the Supreme Court's overturning of prohibitions against physician assisted death (PAD), let us stand with our bishops against all forms of assisted suicide and euthanasia.

Let us stand with Catholic physicians and other healthcare professionals who refuse to be bullied into taking part in this culture of death.

The time is now Brothers!


As we close yet another year of the Soccer Challenge, I want to congratulate all the participants from all the Councils at both District and Regional levels.
