During his remarks at the 138<sup>th</sup> Convention, Supreme Knight Carl Anderson announced Knights donated more than \$187 million and volunteered more than 77 million hours in 2019. Supreme Knight Anderson added that an independent analysis put the value of the volunteer hours at more than \$1.9 billion.
