Resolution #10

Support for the Compassionate Community Care Charity

Submitted by: Ontario State Council

Whereas: in the past, Knights of Columbus Ontario Annual Conventions have passed resolutions opposing euthanasia and assisted suicide on several occasions. Euthanasia, known as Medical Assistance in Dying (MAiD), is quickly becoming normalized in society. Sadly, some Catholics and Knights of Columbus members have died by euthanasia, often based on depression, loneliness, hopelessness and the feelings that life has lost meaning, purpose or value;

and

Whereas: to combat euthanasia and to recognize the reality of loneliness and isolation among our own brothers who are living with sickness, disability or health limitations, the Ontario State Council created the Senior Program to encourage councils to visit our brothers who are sick or have become less mobile due to age or disability;

and

Whereas: the, Compassionate Community Care charity provides a Visitor Training program, an Advocacy Training program and it offers a toll free help-line for people concerned with end-of-life medical questions. When visiting elderly brothers or parish members, who the visitor does not know personally, it is necessary to receive training in order to safeguard both the visitor and the person being visited. Compassionate Community Care provides a training program at no cost, and they regularly offer it through online training sessions;

and

Whereas: the Ontario State Council urges councils to participate in the Seniors Program by actively visiting their sick or elderly brothers. We recognize that loneliness and isolation are leading reasons that people are seeking a death by euthanasia. We are committed to building a culture that cares, not kills;

Therefore, be it resolved: that we, the members of the Knights of Columbus, assembled in the Annual State Convention will urge council members to contact the Compassionate Community Care charity and sign up for their Visitor Training Program and possibly their Advocacy Program;

Therefore, be it further resolved: that while no one is required to participate in the Senior's Program, it is recognized that the normalization of euthanasia has spread throughout Ontario and one of the best ways to protect our own is by visiting, being with and caring for

our brothers and fellow parishioners in need;

Therefore, be it further resolved: that members and councils make charitable donations to the Compassionate Community charity to enable them to continue its life-saving work.



Resolution #11 Nomination for Horace Joseph Gaul

into the Canadian Hockey Hall of Fame and the Ottawa Sports Hall of Fame

Whereas: Horace J. Gaul was a member of the city of Ottawa Emmett hockey team for 3 years which, coincidentally, won the city of Ottawa Senior League championship for those same three years;

and

Whereas: Horace J. Gaul was a member of the Ottawa Silver Seven for 2 seasons 1904 – 1905 and 1910 – 1911. His team won the Stanley Cups both years;

and

Whereas: Horace J. Gaul was the leading scorer in the International Professional Hockey League in 1906 – 1907 when Gaul played for the Pittsburgh Professionals Hockey Club in Pennsylvania;

and

Whereas: during the 1909 – 1910 season, he played for the Haileybury Miners. That season, he scored a team-leading 20 goals in 12 games placing him seventh overall in the National Hockey Association (NHA);

and

Whereas: Horace J. Gaul was a member of the Ottawa Capitals' Lacrosse Team which won the Minto Cup in 1906;

and

Whereas: Horace J. Gaul was a veteran who served with distinction during the South African War (1899 – 1902) and again during the Great War (1914 - 1918) where he suffered a serious and debilitating injury which ended both his military and sports careers;


and

Whereas: Horace J. Gaul joined Council #485 in Ottawa of the Knights of Columbus on April 23, 1918 and served as a secretary for the Knights of Columbus Canadian Catholic Army Huts program overseas.

Resolution #12 Gambling - Concern of Sport Betting and Sport Betting Advertising

History: Over the last few years with the pandemic being prevalent, casinos have seen their revenues drop. They have come up with a plan to boost profits by providing on-line gambling. They use celebrities like Wayne Gretzky and Connor McDavid to make on-line sport betting attractive. They have also bought up commercial time at a rate that is sending subliminal messages to encourage betting.

Whereas: gambling can become addictive;

and

Whereas: there is an onslaught of ads on television using celebrities to make gambling look attractive:

and

Whereas: the profits go directly to casinos unlike OLG where profits go to the province;

and

Whereas: gambling odds are not great, 96% of people lose, 2% break even, 1% win a small amount and 1% win more:

and

Whereas: gambling can lead to bankruptcy, depression and even suicide;

and

Whereas: ads for cigarettes have been removed from television and other media;

Therefore, be it resolved: that the K of C Ontario State Board approach the Provincial and Federal Governments to regulate gambling ads and their content or remove them entirely;

Therefore, be it further resolved: that the Ontario State Board approach the CRTC to regulate gambling ads and their content;

Therefore, be it further resolved: that the Ontario State Board publish in their newsletter the dangers associated with gambling.



Resolution #13 The Transfer-In of a member into any

Council shall be a full credit towards receiving the Council Membership Quota

Whereas: all Councils are required to obtain an annual quota to increase membership annually;

and

Whereas: all Councils are required to conduct a minimum of two membership drives each year to sustain that membership growth;

and

Whereas: as a Council increases in number through growth the membership quota is increased making it more difficult to maintain its quota;

and

Whereas: when Councils are first created many of its members are existing Knights who transfer-in from the neighboring Councils and the new Council gets full credit for all its charter members new and Transfer-in members:

and

Whereas: councils are under pressure to maintain their growth and are encouraged to innovate their processes to draw men into the Order;

and

Whereas: a great many Councils over the years have been deprived of the Star Council Award for not including the Transfer-In members even though their Council roster shows an increase of membership which equals or exceeds the quota;

and

Whereas: Councils who innovate their membership processes and create an environment to harbor and promote comradery, by their actions these Councils are prone to encourage Knights from other Councils to transfer-in to their Council;

however, these very Councils are penalized by having their quotas increased instead of being rewarded.

Therefore, let it be resolved that: all Councils ought to be encouraged and rewarded when they increase their membership;

Therefore, be it further resolved that: all Councils who have created an endearing and positive environment which has caused members of other Councils to transfer to their Council, as well as other reasons, should be allowed to use the Transfer-In member to satisfy its membership quota;

Therefore, be it further resolved that: such Transfer-In of a member shall be a full 1 to 1 credit towards the Councils membership quota;

Therefore, be it further resolved that: such 1 to 1 credit should be calculated towards Star Council qualification;

Therefore, be it further resolved that: such incentive should be Order wide

Therefore, be it further resolved that: such policy should be made retroactive to the 2022 - 2023 fraternal year;

Therefore, be it further resolved: that if this resolution be adopted the proposed changes will be put into place as soon as possible.

Whereas: the Catechism of the Catholic Church (sections 2221-2229) teaches that parents have the primary duty to educate their children, that they have the right to choose an education in accord with their convictions, and that public authorities have a duty to protect this right;

Whereas: the Assembly of Catholic Bishops of Ontario in conjunction with Catholic educators and trustees released in 2012 the "Respecting Differences" resource;

and

Whereas: in February 2015, the Archbishop of Ottawa, voicing the concern of many Catholics, stated that the new Ontario sexual education curriculum as then proposed threatened the "fundamental right of parents to educate their children in the moral dimension of sexual behaviour":

and

Whereas: in April 2016, the Assembly of Catholic Bishops of Ontario released guidelines for sexual education in Catholic schools, affirming the rights of parents and the importance of fidelity to Church teaching;

and

Whereas: in July 2018, the Assembly of Catholic Bishops of Ontario reaffirmed the role of parents as the primary educators of their children, and prayed that elected officials would listen intently to all voices in developing a new curriculum;

and


Whereas: the, Knights of Columbus is a Catholic fraternal organization, which upholds the teachings of the Catholic Church and the rights of Catholic parents;

Condemnation of Freemasonary Resolution #21

Freemasonry is a superstition, a misconception not only gross and universal, but so profoundly mischievous as to misdirect an immense part of the energies of mankind and to misdirect them to such a degree that unless we liberate ourselves from its influence, Western civilization itself will be threatened.

Regrettably many Freemasons continue to be pawns and scapegoats for their deceitful leaders. For this reason, Freemasonry must be understood for what it really is - not based on an elaborate theorem – but upon the simple exposition of the following facts:

Whereas: Popes have issued more condemnations and warnings about the plotting of the Freemasons against the Church than any other single subject in Church history. These condemnations are also so severe and so sweeping in their tenor as to be quite unique in the history of Church legislation. The most prominent include the following:

Whereas: Pope Benedict XVI, on November 26, 1983, when he was Prefect, stated: "Therefore the Church's negative judgement in regard to Masonic association remains unchanged since their principles have always been considered irreconcilable with the doctrine of the Church and therefore membership in them remains forbidden. The faithful who enrols in Masonic associations are in a state of grave sin and may not receive Holy Communion."

and

Whereas: regarding democracy in Western civilization: Freemasons have a history of supporting or carrying out violent political acts with the aim of establishing a one-world government. These violent acts include, but are not limited to, the following:

- 1789, The First French Revolution.
- 1820, The publication of the anti-Catholic Permanent Instruction of the Alta Vendita.
- 1825, The First Revolution in Russia
- 1830, The Second French Revolution
- 1848, The European Revolution
- November 15, 1848, Assassination of the Pope's Minister of Justice Count Pellegrino Rossi.
- 1864, World Revolution through the First Internationale.
- 1871, The Third French Revolution (Paris Commune).
- 1872 The Second Revolution in Russia.
- 1875, Assassination of President Garcia Moreno of Ecuador.
- 1908, Assassination of Portugal King Dom Carlos and his son Dom Felipe.
- 1910, Revolution in Portugal
- 1909 The Freemason-lead Barcelona riots.
- 1913-1915, Mexican Civil War.
- 1914, Assassination of Austria's Archduke Franz Ferdinand causing the Great War (1914-1918). The assassin, Gavrilo Princip Philip, was a member of the Masonic Black Hand society.
- 1915, The establishment of the Masonic inspired Ku Klux Klan whose founding leader was an ex-Methodist preacher and Freemason was William Joseph Simmons.
- · November 4, 1925, Zaniboni plot to assassinate the Italian Premier Minister was financed by Freemasons.
- 1913-1915, Mexican Civil War between Carranza and the Freemasons against Catholic President Victoriano Huerta.
- 1926-1929 Cristero Civil War in Mexico. Freemasons supported the persecution of the Hierarchy by the socialist Mexican government.

Whereas: regarding education in Ontario schools, Freemasonry opposes instruction in the French language and opposes separate schools in favour of public education which has shifted from Western traditions to indoctrination.

"We know that many periodicals published, if not with the authority of Masonic jurisdictions, then at least with their support, have carried on a bitter campaign against the parochial school. The evidence abounds. I do not believe that the average member of the Masonic order subscribes to this vicious propaganda against the God-fearing Catholic fellow-citizen. None the less, the propaganda goes on." Supreme Knight Flaherty Columbia Magazine, January 1923.

and

Wheras: regarding politics, November 1916, the Masonic Journal, called Sentinel, cited the "... aggressiveness of the Knights of Columbus in placing their members and other Catholics in public office. [As such], the Masons pledge themselves to take action and stand [wherever] possible to discontinue the possibility of Catholic people becoming a power."

and

Whereas: one of the tools that Pope Leo XIII used against Freemasonry was prayer. In 1886, he instituted a prayer to the Archangel St. Michael, which was to be recited at the end of every Low Mass. The St. Michael prayer came about after an incident where the Pope collapsed to the floor with no sign of a pulse for several moments. Upon regaining consciousness, he shared the vision he experienced relative to the future: "He saw the ages to come, the seductive powers and ravings of the devils against the church in every land. But Saint Michael appeared in the moment of greatest distress and cast Satan and his cohorts back into the abyss of hell."

and

Whereas: it is not the intention of this resolution to denigrate the many good and decent members in the lower masonic degrees who are unaware of Freemasonry's true function, there is, nonetheless sufficient evidence and testimony as to Freemasonry incompatibility with Catholicism and Western civilization.

Therefore, be it resolved: that we, the Members of the Ontario Knights of Columbus, in State Council Convention assembled, reaffirm that one cannot be a member of the Catholic Faith and a member of the Knights of Columbus and instruct all members of the Catholic Faith to refrain from participation or membership in organizations with teachings, oaths, or mythical knowledge which are contrary to the Bible and to the public expression of our Faith in the gospel of Jesus Christ, which must be above all reproach.
